Sealed tenders from reputed, well experienced and financially sound Indian or Maldivian vendors/service providers registered with the Indian/Maldivian Govt., as the case may be, are invited by High Commission of India, Maldives on behalf of the President of India for Token System for Que Management for consular services at High Commission of India, Maldives
- 2. Interested firms may submit their bids complete in all respects after carefully reading the Tender Notice by providing bid in specified format, separately, clearly mentioning <u>Bid For Token System for Que Management</u>. Such proposals are to be submitted in High Commission of India, Male 'within the stipulated date and time as mentioned in the Tender Notice as given in CRITICAL DATE SHEET.

The decision of the High Commission of India, Maldives in this regard shall be final and binding on all parties in all circumstances.
- 5. Earnest Money Deposit: **US\$** 300.00. EMD Should be deposited in the form of DD/Banker's Cheque in the name of "High Commission of India" payable at Male', Maldives (Exemption from payment of EMD permitted as per Government of India regulations). EMD of disqualified bidder will be returned to the bidder within one week of disqualification.
- 6. If the tenderer fails to supply the ordered quantity within the stipulated time period/supplies sub-standard item, liquidated damages equivalent to 1% (one percent) of contract/bill value shall be charged per week after completion of 6 weeks of placement of work order and deducted from the bills of the contractor subject to maximum of 10% of contract/bill value. If any of the assigned work is not found satisfactory or damages to the items are recorded within 7 days delivery of items, an appropriate amount shall be deducted for every major

deficiency/damage from final settlement of payment. The amount to be deducted for damage/deficiency will be arrived at after mutual discussion.

- Tenderer shall have to quote item wise rates, consolidated rates shall not be considered and tender shall be liable to be rejected out rightly.
- High Commission of India reserves the right to change the quantity/ upgrade the criteria/drop any item or part thereof/extension of delivery date at any time before placing the purchase order.
