The High Commission of India in Cyprus has the pleasure to invite you for and on behalf of the President of India, to submit a Tender in competition, on Lump sum Tender Price for the Supply and installation of six cooking ranges for the New Building for the Staff Residences for the Indian High Commission at no.10, Ledas Street, Engomi, Nicosia, Cyprus. The Lump sum Tender Price/Amount shall be on the basis of following tender documents.

2. The Tender shall be submitted before **3.00 p.m. on or before on 7th October 2019** at the High Commission of India. Any Tender received after this date and time will not be considered and will not be opened. Any such unopened tender will be returned to the respective tenderer. **Tender shall be opened at 3.30 pm on the last day of submission i.e. 7th October 2019 at the High Commission of India.**

3. The Tender shall remain valid for a period of ninety (90) days from the date of opening or any extended period.

4. The Tenderer shall quote the Lump sum Tender Price Amount based on the tender documents.

5. Commencement date of the works shall be effected from the date of issue of the acceptance letter of intent.

6. The Period of Completion for the whole of the Works is 30 calendar days calculated from the Commencement date.

7. The Employer will not be bound to accept the lowest or any tender nor to give a reason for the rejection of any Tender.

8. The successful tenderer will be responsible for delivering the goods at the New Building of the High Commission, on 10, Ledas Street, Engomi Nicosia, fitting and placing the goods as per the Architects instructions. The successful tenderer will also be responsible for the removal of all the packaging of the goods to a legally licensed waste site, unless the Employer decides otherwise. It is noted that the successful tenderer will provide samples of all the materials to be used. All these have to be approved by the architect beforehand.

9. The Defects Notification Period shall be two years.

10. The English language is to be used for the needs of this tender. Therefore, all supporting documents must be in English. No other language will be accepted.

SPECIFICATIONS

The following specifications and conditions must be met and priced by all tenderers:

1. All goods must be provided by a country that is member of the European Union and all items must have the CE marking.
2. All tenderers and their suppliers must comply with the relevant ISO and quality standards.
3. The successful tenderer must make on site precise measures before supplying all the Kitchen Equipment.
4. The successful tenderer must supply, install and fix all kitchen equipment.
5. The successful tenderer must include in the tender all the technical specifications of the kitchen equipment for cooking.
6. The set of items that will be included in the tender must be of the same brand name.
7. The applicant should have sufficient number of Technical and Administrative employees for the proper execution of the contract.
8. The successful tenderer must supply a guarantee for at least 2 years. All faulty equipment will be free of charge within the guarantee period. All responsibilities by the supplier will be in accordance to the European directive on Consumer guarantees.
9. The supplier must also ensure that spare parts will be available for a minimum of five years.
