2. The Tender shall be submitted by **3.00 p.m. on or before on 3rd** January 2020 at the High Commission of India. Any Tender received after this date and time will not be considered and will not be opened. Any such unopened tender will be returned to the respective tenderer. Tenders shall be opened at 1030 hrs on 6th January 2020 at the High Commission of India.

3. The Tender shall remain valid for a period of ninety (90) days from the date of opening or any extended period.

4. The Tenderer shall quote the Lump sum Tender Price Amount based on the tender documents.

5. Commencement date of the works shall be effected from the date of issue of the acceptance letter of intent.

6. The Period of Completion for the whole of the Works is 60 calendar days calculated from the Commencement date.

7. The Employer will not be bound to accept the lowest or any tender nor to give a reason for the rejection of any Tender.

8. The successful tenderer will be responsible for delivering the goods at the New Building of the High Commission, on 10, Ledas Street, Engomi Nicosia, fitting and placing the goods as per the Architects instructions. The successful tenderer will also be responsible for the removal of all the packaging of the goods to a legally licensed waste site, unless the Employer decides otherwise. It is noted that the successful tenderer will provide samples of all the materials to be used. All these have to be approved by the architect beforehand.

9. The defects notification period shall be three months

10. The English language is to be used for the needs of this tender. Therefore, all supporting documents must be in English. No other language will be accepted. 10. Any further information or clarification which the Tenderer may require in order to complete his/her Tender may be obtained from:

SPECIFICATIONS

The following specifications and conditions must be met and priced by all tenderers:

- 1. All tenderers and their suppliers must comply with the relevant ISO and quality standards.
- 2. The successful tenderer must make on site precise measures before the ordering, cutting and fitting of the curtains.
- 3. The successful tenderer must supply, install and fix purpose made curtains for each opening.
- 4. The successful tenderer must supply, install and fix purpose made heavy duty aluminium single and twin curtain rails with heavy duty runners.
- 5. The successful tenderer must provide to the architect, Colakides & Associates, samples and certificates with technical specifications, for all materials for approval, within two weeks of the award of contract and before the ordering, cutting and fitting of the curtains and of the curtain rails.
- 6. Colours, designs and patterns must be to the approval of the architect.
- 7. Curtains of dining/living rooms and bedrooms must be double curtains.
- 8. Curtains of kitchens must be single dim-out curtains.
- 9. The "outside" curtains must be minimum 95% blackout curtains and they must be one and a half times wider than the width of the windows.
- 10. The "inside" curtains must be translucent sheer and they must be two times larger than the width of the windows.
- 11. The height of the curtains in the bedrooms and of the large openings of the living/dining room must start from the floor and up to 30cm above the openings. The width of all curtains must start and end 15cm outside of each opening. These dimensions are additional to the ones shown in Schedule of Openings.
- 12. All curtains must be blocking at least 95% of the light, fire retardant, washing machine washable, made of polyester and contract textiles.
- 13. The attached Schedule of Openings makes reference to 2 types of curtains which are the following:


